## Resource Mobilization Policy

The college is aided by the Govt. of Maharashtra and included under section 2f and 12B of the UGC Act, 1956. It is fully eligible to receive the grants under various schemes of UGC. The college mobilizes funds for its regular activities from various agencies. Apart from this, the college mobilizes funds through DBT star college scheme, Dr. B. A. University Aurangabad fund for program, alumni contribution, individual's donation and self-financed courses etc. For generation of funds the college is implementing certain policies and strategies for optimal utilization of resources and mobilization of funds.

1. The college generates financial resources through its stake holder's government, NGO, Affiliated University, UGC, local well-wishers, alumni, public representatives, etc.
2. The parent institute helps us to mobilize fund to create well furnished campus for the students. The IQAC and CDC committee are trying to develop the new ways and procedure for mobilizing funds and optimal utilization at these resources.
3. The college's mother institute has registered under societies Act 1860 and Bombay Public Trust Act 1950 the donation given to the college is permissible under 80G for Income Tax deduction.
4. The college has used transparent mechanism of audit and specific committee for utilizing this grand and resources. The college has tried to generate funds inform of money and objects.

**Policy and Procedure for Resource Mobilization:**

The College has spread in 6 acres campus in center in the city of Osmanabad. As per the guidelines of the institution the college takes initiative to raise the funds. The CDC member, teaching non-teaching staff, alumni students contribute to mobilize the resources for college. Students' tuition fees, DBT star college scheme, gratitude funds, short term courses fees and the college development funds are the primary sources of fund, all the these stakeholders activity rich out in the community and appeal to the philanthropist, industrialist and donors. Income Tax 80G certificate is the effective tool to mobilize the funds.

### **Optimal Utilization of Resource:**

The college has prepared policies for effective implementation and optimal utilization of resources for maintains infrastructure as per the need new trends in education. Maintaining the cleanness of the classroom and campus of the College is through permanent and contractual employees. The funds are collected and utilized through the D.D., cheque, RTGS, NEFT mode only.
